The municipally-owned site is strategically established along Highway 21 in the community of Forest, only an 11-minute drive to provincial Highway 402 and in proximity to Sarnia, London, Windsor, and the US border. The town of Forest is a major service centre for the surrounding community, as well as a central commercial area and home to a cluster of agriculture and industrial manufacturing companies. An additional 32-acres to the west of the site may be available for development.

ELECTRICAL

276kV feeder that runs along Rawlings Road. The site is serviced by Hydro One.

NATURAL GAS

Existing 4 inch natural gas pipeline along Rawlings Road and a second 2 inch pipeline located at the southwest corner of the site. Pipelines operated at up to 420kPag serviced by Enbridge Gas.

WATER

Serviceable by 200mm watermain located 40 metres from the site.

SANITARY

Serviceable by 200mm sanitary sewer located 70 metres from the site.

FIBRE

Eastlink telecommunication servicing available at Rawlings Road & Enterprise Drive.

Property is currently used as an agricultural parcel exclusively.
